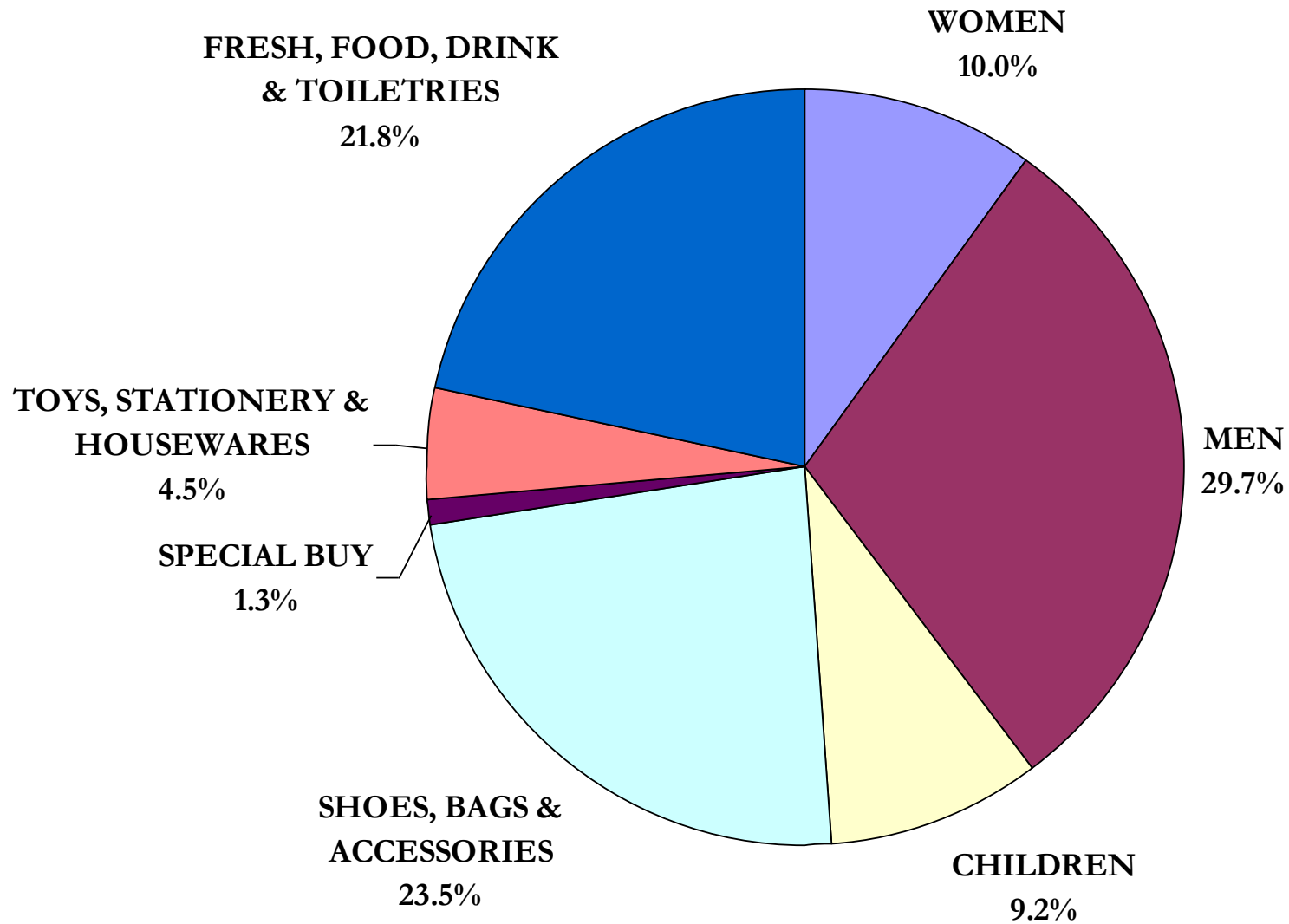

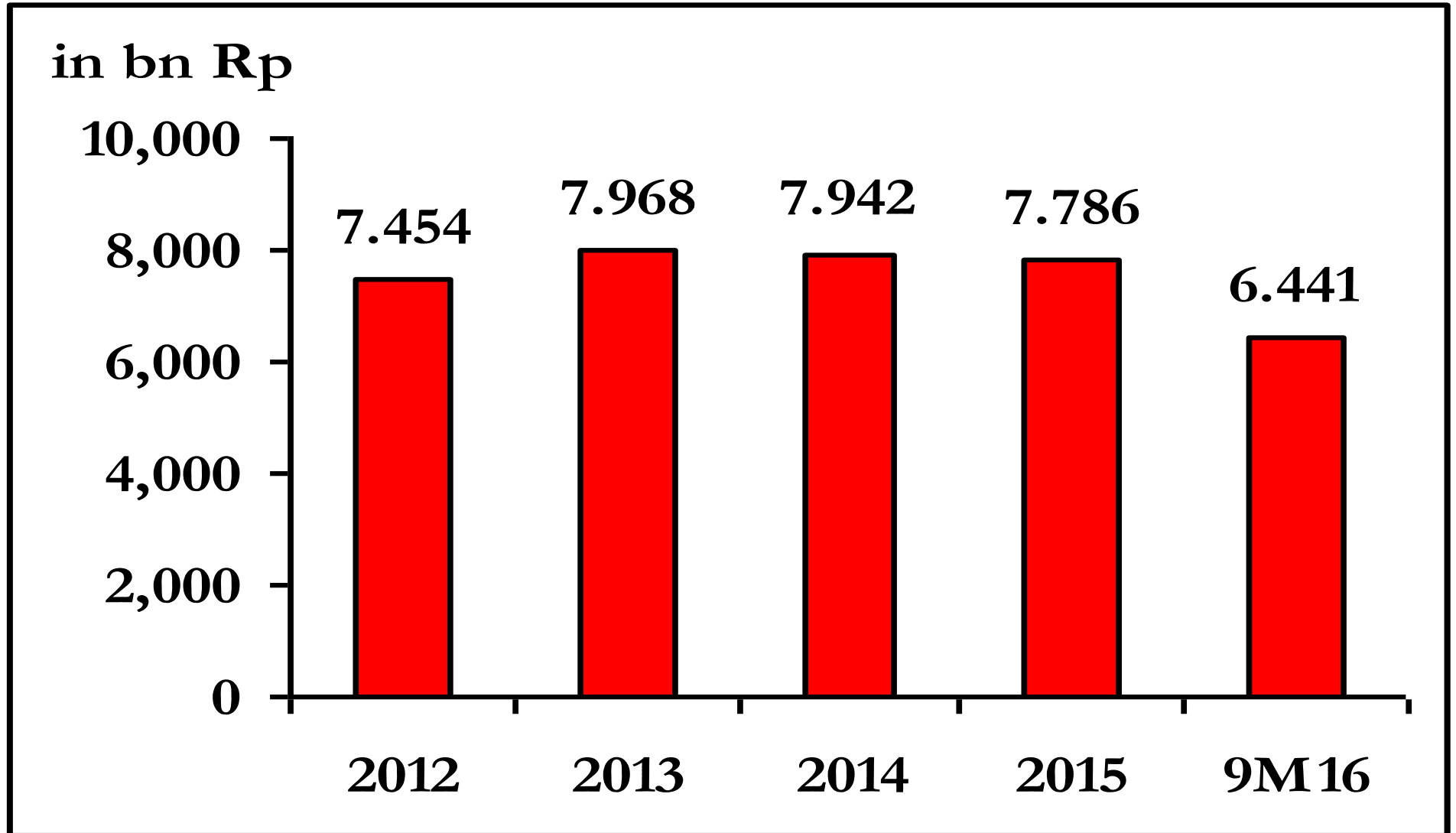

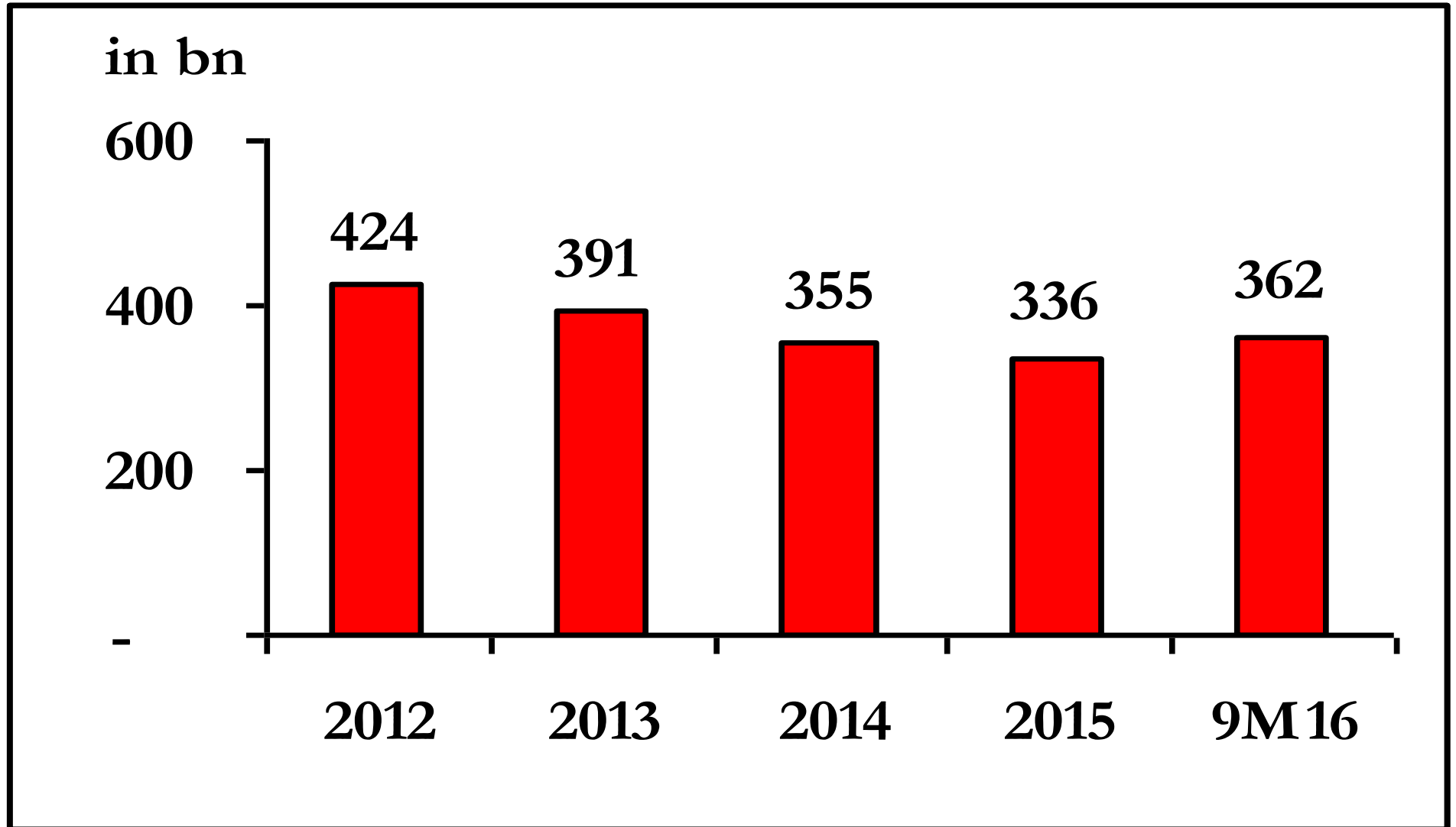

HIGHLIGHTS / PROBLEMS

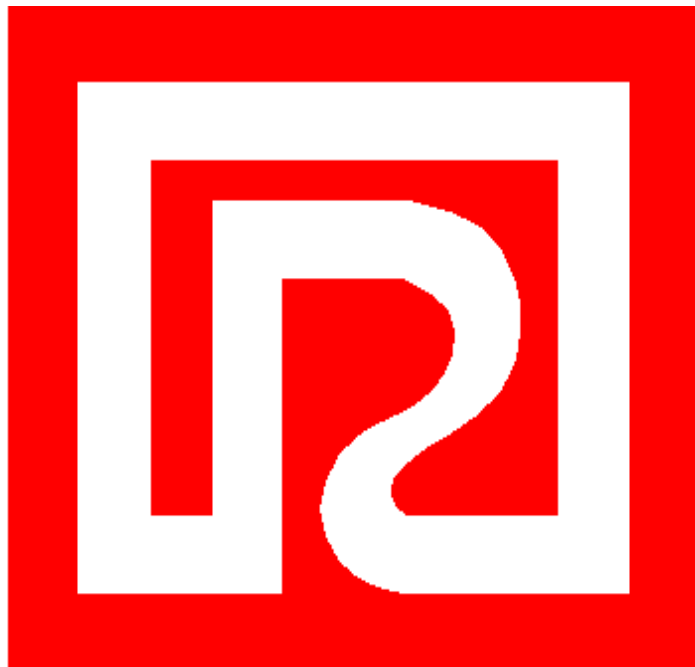


- Overall high increase in minimum wage and low inflation would benefit & increase disposable income of the segment who is targeted by Ramayana.
